#### ITC LAUNCHES CALL FOR EVIDENCE ON UK AVIATION STRATEGY

In response to the Secretary of State for Transport's recent call for a proper investigation into the longer-term choices facing UK Aviation, the Independent Transport Commission (ITC) has launched a major research study that will identify the broad strategic options open to policy makers as well as the key issues they raise. The ITC study will consider all strategic options in its study.

As part of this research, the ITC is today launching a nationwide Call for Evidence on Britain's Aviation Strategy. The ITC invites submissions from businesses, airports, industry, local government, public interest groups and members of the public with an interest in the future of UK aviation. Written submissions are requested before the deadline of 30 September 2012. Following this deadline, a number of spoken evidence sessions will be held by the ITC in Autumn 2012.

The ITC Call for Evidence poses five key questions. First, is there a need for greater aviation capacity in the UK, and of what type? Second, over what timescale do we need to solve our aviation needs? Third, what are the risks of failing to provide additional capacity? Fourth, what are the key criteria for determining environmental acceptability of any development? And finally, if more capacity is needed, what are the main options to solve this and what are the issues they raise?

Dr Stephen Hickey, the Commissioner chairing the research study, explained: "The future of aviation, especially in the south-east of England, is one of the most controversial but critical strategic challenges we face. The ITC is independent and non-partisan and its review will assess the key issues, the choices we face, and their implications. We welcome all those interested or concerned about these key issues to input evidence so that the review can be as authoritative and balanced as possible."

It is expected that the ITC study will form an important contribution to developing a national aviation strategy on which the Government has promised further consultation later this summer.
